Pine View Elementary Electronics Policy Proposal

Elementary students will not be allowed to use personal electronics while on campus. This includes cell phones, iPads, game systems, and smart watches. Students will need to put these items away while on campus, including before school, at lunch or recess, or in classrooms until school is over.

Start Date: January 3, 2017.

* Elementary teachers may direct students to use e-readers or personal electronics if needed for an educational purpose or for communication in an emergency.

This policy will be enforced by:

- Elementary teachers Ask all students to power off electronics and leave them in backpacks during the day.
- Aides Ensure that students are not using electronics while on campus.
- Elementary Assistant Principal Will follow-up and communicate with students, parents, and staff as needed.

Consequences:

- Step One Student receives a verbal warning and a note to bring home.
- Step Two Student's device will be taken to Ms. Rini's office to be signed out by student at the
 end of the day. Student also receives a note to bring home.
- Step Three Student's device will be taken to Ms. Rini's office to be signed out by parent.
 Student also receives a note to bring home.
- Each step, the student will sign their name, acknowledging the receipt of the warning.

These consequences will be enforced by:

- Teachers and Aides Address students when they are observed to have an electronic device.
- Elementary Assistant Principal Will create three versions of note home for each step of consequence. Will also track number of offenses and share with relevant Elementary Faculty and Aides the names of students who are on Step 2 or 3.

Ways we will ensure this policy change is successful:

- Brand the policy as a positive, not a negative. "Heads Up, Pine View!"
- Letter sent home to elementary families the week before. Letter will explain: process of
 researching policy change, rationale for policy, our desire to work with the families for the
 betterment of the students and the school, solicit volunteers who want to try to help implement
 interactive alternatives, and the steps of the consequences.
- Teachers will explain policy to their classes the week before.
- Elementary Assistant Principal will coordinate with any volunteers some alternate activities, perhaps once a week, depending on participation. Suggestions/examples include:
 - Make signs for tables to encourage kids to sit in different places at lunch.
 - Cooperative games to learn names.
 - o Add new equipment to playground hula hoops, chalk, jump ropes, balls, jacks
 - o Look into allowing kids to use 2nd/3rd grade playground on occasion
 - o Interested teachers can offer their classrooms as a place to come inside and play
